## QUESTIONS AND ANSWERS

### Existing & New Orders

**1. What about my pre-existing purchase orders issued to Desser?**

Any PO issued to Desser Tire & Rubber before the asset transfer will be honored. Orders shipping on or after August 19, 2024, will reflect the VSE Aviation, Inc. entity. Further, any payments made after August 19<sup>th</sup> should be made only to **VSE Aviation, Inc.**

**2. Do I send my orders using the VSE Aviation, Inc. name?**

Yes, please place orders with your legacy-Desser contact using the **VSE Aviation, Inc.** name.

**3. Do I need to register on [shop.vseaviation.com](https://shop.vseaviation.com) if I already have an account with [shop.desser.com](https://shop.desser.com)?**

Yes, you will need to create a new account on [shop.vseaviation.com](https://shop.vseaviation.com), even if you previously made purchases on [shop.desser.com](https://shop.desser.com). As our new e-commerce site evolves, you will enjoy an even more enhanced and seamless shopping experience.

### Quality Assurance

**4. Has the Quality Manual changed?**

No, our QMS and QA Manual content remains the same. Only the legal entity name and logo have changed. The updated Quality Manual is available upon request.

**5. Are all quality accreditations flowing to the VSE Aviation, Inc. entity? YES Is re-certification necessary? NO**

**6. Do manufacturer and supplier certs show traceability to Desser after August 19<sup>th</sup>?** Yes, all previous certification received prior to the asset transfer remain as Desser. You may continue to rely on manufacturer and supplier certs that reference the Desser entity after August 19<sup>th</sup>. Going forward, certifications will show traceability to the VSE Aviation, Inc. entity.

**7. How should I process RMAs?**

RMAs should be processed with your legacy Desser representative. Products should be returned to the address listed on the RMA confirmation form and a credit will be available on your existing account.
